

Texas Department of State Health Services Grant Required Courses

For entities that contract or receive grants from the Texas Department of State Health Services, the Statement of Work attached to your contract includes specific training requirements for treatment and prevention providers. DSHS requires that newly hired prevention staff receive their initial 15 hours of training from the Coordinated Training Provider. All annual prevention training may be provided through BHC or other training providers. Treatment providers have no restrictions as to where they may obtain their training, with the exception of the COPSD providers. COPSD training must be approved through DSHS.
